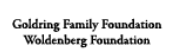
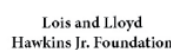

# YOUTH SUMMER CAMP REGISTRATION REQUIREMENTS

Requirements 1-5 must be met to register through NORD for NOBA's Adventures in Dance Summer Camp

**1) Proof of Income** – (Must have 2025 year on documentation) This requirement can be satisfied by submitting one of the following:

- SSI Award Letter with monthly amount.
- Food Stamp or Social Security Award Letter with amount and 2024 dates for distribution
- Retirement Letter with monthly benefit amount
- Photocopy of 4 consecutive paycheck stubs for ALL adult members of the household
- If unemployed, must provide a letter from La. Workforce Commission, dated 2024, regarding unemployment status and employment benefit amount or provide a notarized letter stating current income.
- If self-employed/business owner, must provide a notarized letter stating current gross monthly income.
- If there are 2 parents/guardians, must provide proof of income for both parents/guardians.
- No Tax documents will be accepted.

**2) Proof of Residency in Orleans Parish** – must have 2025 year on documentation. This requirement can be satisfied by submitting one (1) of the following:

- Photocopy of utility bill, phone bill, current home insurance statement, or pay stub documentation with the parent/guardian current Orleans Parish address. The address on the document provided must have the same address provided on the registrant's application.

**3) Identification Verification** – This requirement must be satisfied by submitting the following:

- Photocopy of a valid State-issued Identification Card or Driver's License for parents and/or guardians
- If there are 2 parents/guardians, provide such documentation for both parents/guardians.

**4) Report Card** – The requirement can be satisfied by submitting the following:

- Photocopy of each child's report card from current school year (2024-2025)
- If the child is not of age to attend school or is homeschooled, an up-to-date copy of the child's immunization record must be provided.

**5) Child's Birth Certificate**

**6) Registration Fee** (\$60 for NOBA Adventures in Dance Camp) -

- **NOTE:** *This fee is NOT collected by NORD with application and materials during the Summer Camp Expo on March 8; instead, it will be collected by NOBA at a later date as the final step of the registration process.)*

**\*\*PLEASE NOTE THAT ALL REQUIRED DOCUMENTATION MUST BE ON HAND AT THE TIME OF REGISTRATION IN ORDER TO ENROLL CHILD(REN) INTO SUMMER CAMP. NORD WILL NOT ACCEPT INCOMPLETE APPLICATIONS!**

**\*\*IF REGISTERING MORE THAN ONE (1) CHILD FROM THE SAME HOUSEHOLD, COPIES OF ALL DOCUMENTS FOR EACH CHILD BEING REGISTERED MUST BE PROVIDED.**

**\*\* IF REGISTERING YOUR CHILD(REN) FOR MORE THAN 1 CAMP, YOU MUST BRING COPIES OF ALL DOCS FOR EACH CAMP THAT YOU'RE REGISTERING FOR.**

**NORD WILL NOT MAKE COPIES ON SITE; ALL COPIES MUST BE BROUGHT IN.**
